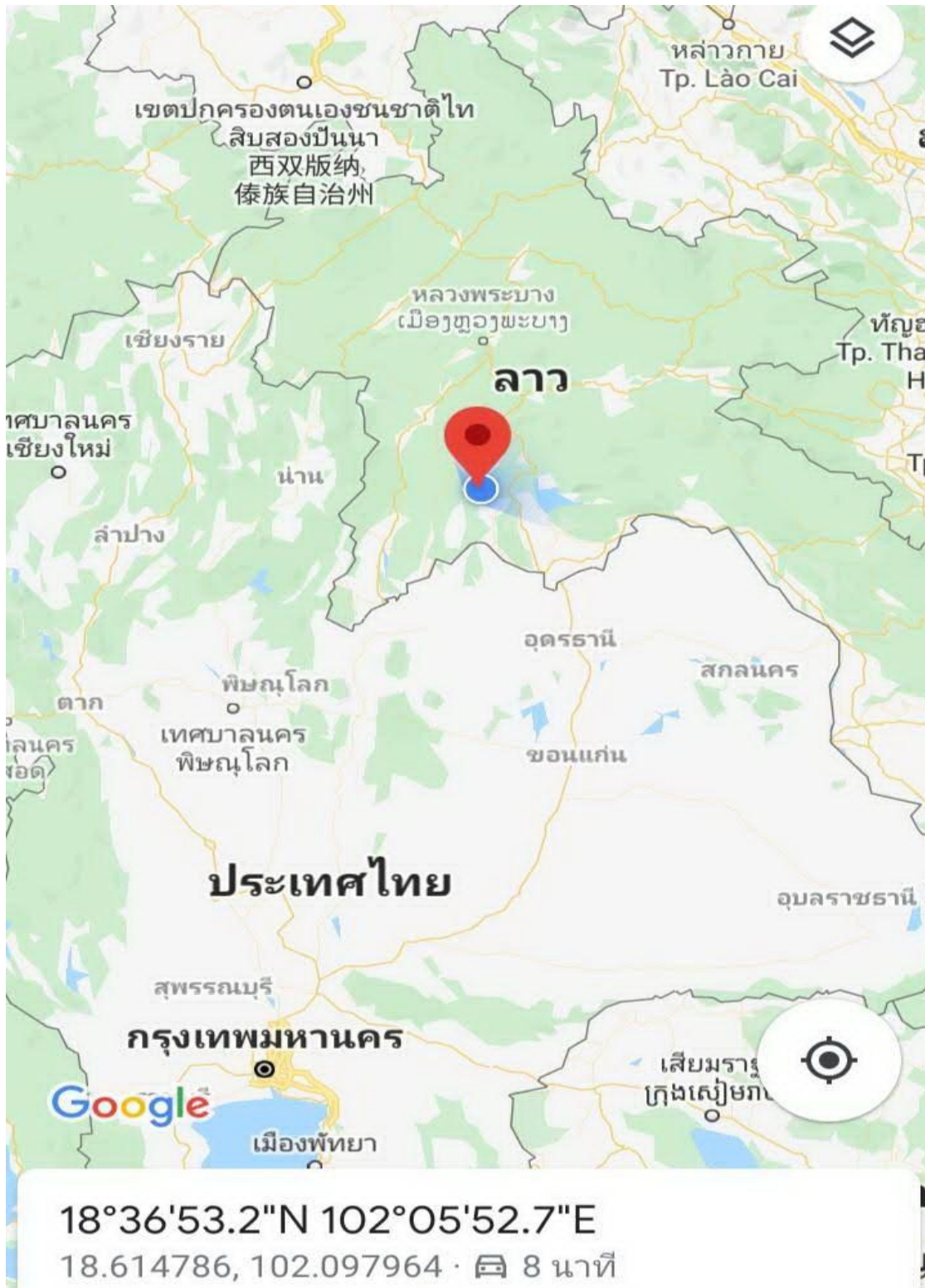

## LOCATION OF COAL MINE





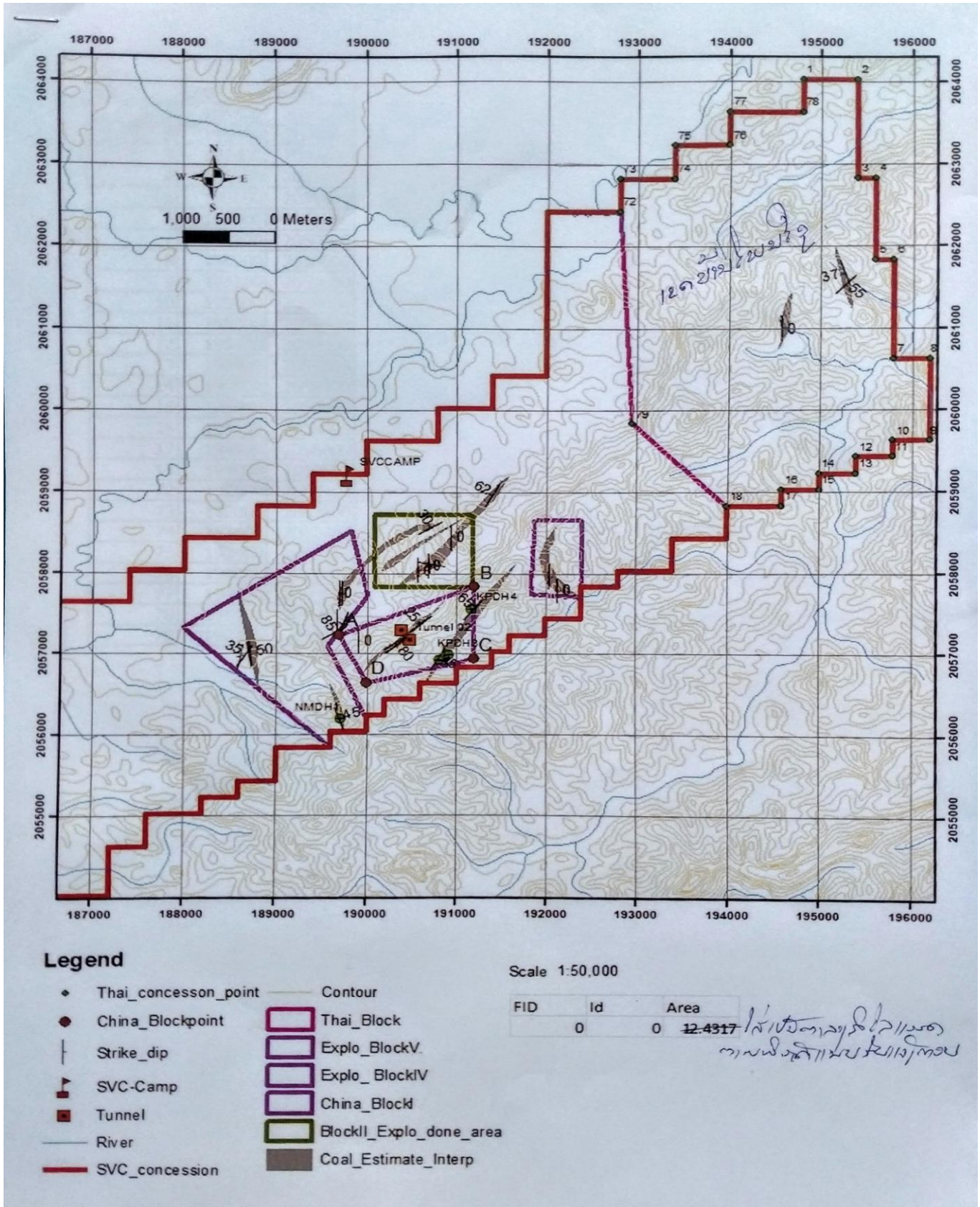
